Seminar costs

LEGACY of LOVE MINISTRY IMPACT

A Midwestern church recently received a \$500,000 gift to fund an endowment. The church will receive approximately \$30,000 each year, which will be designated to support women and children ministries.

As a result of an Abundant Living seminar in Idaho, a member donated real estate valued at \$125,000 to the Nazarene Foundation. The land was sold and the proceeds were placed into a Donor Advised Fund. By donating the land, the donor paid no capital gains tax on the transaction, and the proceeds were then given to the local church to pay off the outstanding debt on the worship center.

A husband and wife in Washington set up a charitable remainder unitrust with \$1 million in real estate, which will generate income for them to live off of in retirement. At their death, the unitrust will fund an endowment which will benefit the JESUS Film Harvest Partners project.

In Colorado, a woman made a bequest in her will and left her house to her local church. The church will receive approximately \$250,000 once the house is sold.
